GENERAL INFORMATION

All Bids must be submitted by digital or postmarked by Friday 10/8/21. All bids must be sealed and marked in the lower left-hand corner "BID – Horsley and Parris Renovation" with opening date and time. Late bids will not be opened.

Records showing successful bidder(s) and prices quoted will be placed on file and may be examined upon request. If contract is awarded to someone other than lowest bidder, a note of explanation will appear in the bid file and Board Minutes.

SCOPE OF SERVICES

The company to be contracted by Central Alabama Wellness will be expected to provide the following services:

1. Replace up to 10 units of damaged exterior wood
2. Prep and stain wood exterior, including eaves, deck and trim.
3. Remove and haul away old windows
4. Replace window units
5. Insulate, window units where necessary
6. Removal of any debris and site clean-up

Quality, conformity with specifications, purpose for which required, terms of delivery, and past service and experience are among the factors that may be considered in determining the responsive bidder. No bid may be withdrawn after the scheduled closing time for the receipt of bids for a period of sixty (60) days.
