#### **SCOPE OF SERVICES**

Scope of work for Katherine Vickery Residential Group Home: Bathroom remodels

- 1) Replace all necessary fixtures ( toilets, sinks ,light fixtures, ect..)
- 2) Inspect all plumbing and repair as needed.
- 3) Replace any rotten wood, Repair any sheetrock and prep walls( adjacent bedroom and hall wall)
- 4) Tile all walls in bathroom.
- 5) Repair tile floor as needed.
- 6) Prep and paint tile floor with epoxy flooring with anti-slip flakes.
- 7) Remove zero entry shower Repair flooring and replace or repair all necessary items due to water damage.
- 8) modify shower and shower pan to prevent future water issues.

#### **C. Certifications:**

The Offeror/Contractor must sign and include as an attachment to its proposal the Certifications enclosed with this RFP. The Offer/Contractor must also be insured and bonded.

### **DISQUALIFICATION OF BIDS**

C. Failure to include requested information or other details of the bid.

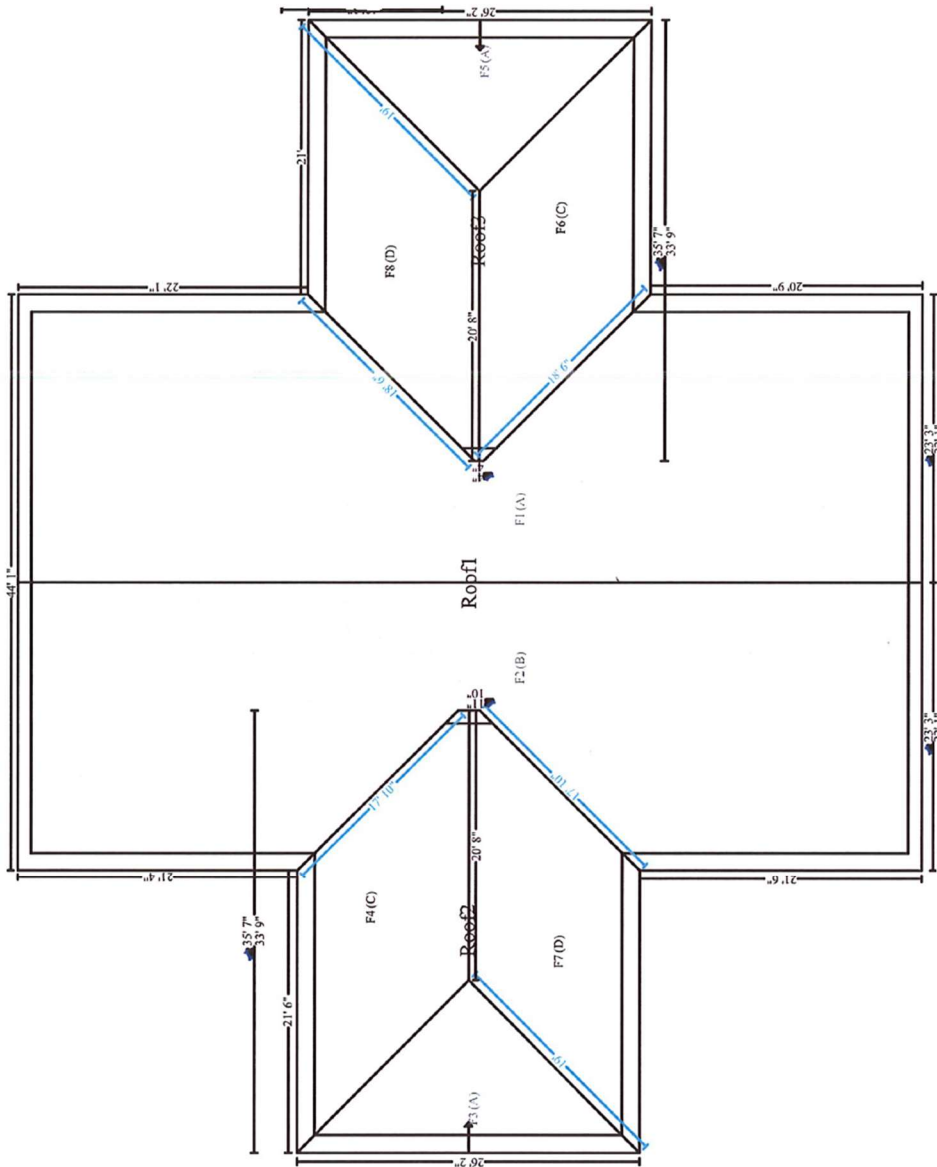
