GENERAL INFORMATION

All Bids must be submitted by digital or postmarked by May 13, 2022. All bids must be sealed and marked in the lower left-hand corner "BID – Admin window" with opening date and time. Late bids will not be opened.

Records showing successful bidder(s) and prices quoted will be placed on file and may be examined upon request. If contract is awarded to someone other than lowest bidder, a note of explanation will appear in the bid file and Board Minutes.

SCOPE OF SERVICES

The company to be contracted by Central Alabama Wellness will be expected to provide the following services:

1. install a plastic barrier to separate work area from patients and staff
2. cut out wall section and prep for additional window.
3. relocate or add any electrical/data as needed.
4. replace sheetrock and install admin window and counter top to CAW specifications.
5. prep and paint all areas associated with this project.
6. Remove any debris caused by installation and any mess associated with replacement.

The award will be made to the lowest responsive bidder meeting specifications. It is not the policy of the Central Alabama Wellness to purchase on the basis of low bid only. Quality, conformity with specifications, purpose for which required, terms of delivery, and past service and experience are among the factors that may be considered in determining the responsive bidder. No bid may be withdrawn after the scheduled closing time for the receipt of bids for a period of sixty (60) days.
