GENERAL INFORMATION

All Bids must be submitted by digital or postmarked by Monday 10/10/2022. All bids must be sealed and marked in the lower left-hand corner "BID – Dock Repair" with opening date and time. Late bids will not be opened.

Records showing successful bidder(s) and prices quoted will be placed on file and may be examined upon request. If contract is awarded to someone other than lowest bidder, a note of explanation will appear in the bid file and Board Minutes.

SCOPE OF SERVICES

The company to be contracted by Central Alabama Wellness will be expected to provide the following services:

- 1. inspect and remove all rotten wood.
- 2. inspect all joist and supports for safety.
- 3. replace all necessary wood with treated lumber.
- 4. report any additional issues that will affect price and notify CAW in timely manner.
- 5. replace hand rails to CAW specifications and code standards.

6.remove all debris related to this project.

OFFEROR'S TECHNICAL QUALIFICATIONS

The Offeror, in its proposal, shall, as a minimum, include the information requested herein:

A. Prior Experience:

Describe the expertise your firm has in providing roofing services to an organization similar to ours.

B. Qualifications:

Provide a narrative stating the reasons why your company should be awarded this contract.

C. Certifications:

The Offeror/Contractor must sign and include as an attachment to its proposal the Certifications enclosed with this RFP. The Offer/Contractor must also be insured and bonded.

DISQUALIFICATION OF BIDS

Bids may be disqualified before award of the contract for any of the following:

- A. Failure to mark envelope as required;
- B. Failure to sign or notarize the bid document;
- C. Failure to include requested information or other details of the bid.

METHOD OF AWARD

The award will be made to the lowest responsive bidder meeting specifications. It is not the policy of the Central Alabama Wellness to purchase on the basis of low bid only. Quality, conformity with specifications, purpose for which required, terms of delivery, and past service and experience are among the factors that may be considered in determining the responsive bidder. No bid may be withdrawn after the scheduled closing time for the receipt of bids for a period of sixty (60) days.
